#### COURSE DESCRIPTION/ OVERVIEW

Physics is the study of matter, energy, and the interactions that shape the universe. In this year-long course, students will build a strong foundation in the fundamental principles of physics through an algebra-based approach. Topics include motion and forces, energy, momentum, waves, electricity and magnetism.

Emphasis will be placed on developing scientific reasoning, problem-solving, and critical thinking skills. Students will engage in hands-on experiments, data analysis, and real-world applications to deepen their understanding of how physics connects to everyday life and emerging technologies.

By the end of the course, students will not only be prepared for future studies in science, engineering, or technology, but will also gain an appreciation for the role of physics in society and the natural world.
