FOR INDIVIDUALS WITH DISABILITIES

If you have a disability and want to work, the **New Jersey Division of Vocational Rehabilitation Services (DVRS)** may be able to assist you. Your **DVRS counselor** will help you identify opportunities available in today's job market and find your career pathway. DVRS will support you in searching for a job that matches your strengths, interests, and abilities. Together, you and your counselor will develop a plan for reaching your employment goals.

ACHIEVE YOUR CAREER GOALS

If you have a physical, mental, cognitive, or other form of disability that causes a significant barrier to employment, you may qualify for the following services through DVRS:

- Assessments to identify your employment-related skills, abilities, interests, and job goals
- Career planning
- Academic or skills training at a college or trade school
- Assistance writing your resume, locating job leads, and improving your interviewing skills
- Trial work experience in the community
- On the job supports, including job coaching
- Support obtaining assistive technologies, such as orthotics, prosthetics, hearing aids, and ergonomic keyboards, that allow you to overcome employment barriers
- Benefits counseling to better understand your Social Security (SSI or SSDI) benefits
- Other services you may need to achieve your employment goals

Once you are hired, supports are available to you and your employer while you learn your new job duties and later to help you maintain employment.
